## **CF-LAB/Active Carbon (30Ltr.) Central Extractor-Filter.**

- **Extractor-Filter for 1-2 dia.160mm or 4-8 dia.75/100mm Extraction-Arms.**
- **Perfect for Cleaning/Degreasing, Conservation, Gluing/Bonding, Moulding, Screenprinting and similar work situations.**
- **Filter Cartridge, with Prefilter-Fleece and 30Ltr. Active Carbon.**
- **The Filter Media can be changed to F9 Filter Cartridge or HEPA H13 Filterbox when/if needed.**
- **Initial Extraction volume 1400-1800m<sup>3</sup>/h.**
- **Clean Air Outlet at the Bottom of the Unit.**
- **Single Phase or Three Phase models.**

## General Information.

A CF-LAB/Active Carbon Extractor-Filter System is an easy way to create a clean environment with clean air. You get 1000m<sup>3</sup>/h through the Hood of one Extraction-Arm or 2x700m<sup>3</sup>/h through two. It is then possible to catch the contaminations from a larger area without moving the Hood.

Laboratories or areas where you just need to exhaust from a small spot at a time.

A CF-LAB/Active Carbon Extractor-Filter System is simple to install. Mount the Extraction-Arm/Arms on the wall. Mount dia.160mm or dia.75/100mm ducting upwards to a dia.200mm Horizontal Ducting. Extend the dia.200mm Horizontal Duct to a place where you can mount the CF-LAB Extractor-Filter. Go down with a dia.200mm Duct to the Unit. Bolt the CF-LAB to the floor and just plug it into an electric socket (1-phase models). 3-phase models have to be connected by a certified electrician.

CF-LAB/Active Carbon Extractor-Filters can be used for all sorts of work where extraction and filtration of Gas and Odours is needed. Perfect for Cleaning/Degreasing, Conservation, Gluing/Bonding, Moulding, Screenprinting, Mixing, Taking Samples, Experiments, Examinations and so on.

The Door has 4 expander locks to make it easy to open and lock. 4 locks make sure that the door is tight.

To replace the Active Carbon Filter Cartridge you open the door and pull the Filter Cartridge out and replace it with a new. Seal Downwards!

The Unit can be equipped with a F9 or HEPA H13 Filter instead of the Carbon Filter if the work situation will change.

## Safety Note.

**Always disconnect the electricity supply before opening the CF-Unit.**

Don't exhaust Sparks or Poisenous Dust.

Use adequate safety clothing when replacing dirty filters.

Dispose of used Filters according to local laws and regulations.

## Range of Application.

The CF-LAB/Active Carbon Extractor Filter is designed for work situations where Gas and Odours is a problem. It is for indoor use. The unit is suitable for Gas and Odours from Cleaning/Degreasing, Conservation, Gluing/Bonding, Screenprinting, Mixing, Taking Samples, Experiments, Examinations etc.

The filtered air can be recirculated into the room as long it is not against local Laws and Regulations.

# Unit Description

## CF-LAB/Active Carbon. Central Extractor Filter.

### Active Carbon 30 Ltr.

CF-LAB/Active Carbon Central Extractor Filter is equipped with a 30Ltr Active Carbon Filter Cartridge with a Pre-Filter Fleece on the outside. It is suitable for filtering gases and odours.

### Application Examples.

1. Cleaning / Degreasing
2. Conservation
3. Gluing / Bonding
4. Moulding
5. Screen Printing
6. Mixing, Measuring, Taking Samples, Examinations etc.

### Replacement Filter Cartridge.

It is time to put in a Replacement Filter when the extraction is not satisfactory or the odours come back. It is easy to change the Filter Cartridge and will just take a few minutes.

### Capacity.

4-8 Flexa/Chemikus Extraction Arms (d. 75/100mm) can be connected to a CF-LAB/Active Carbon Extractor Filter or 1-2 Flexi Extraction-Arms (d.160mm/max.2m).

### Installation.

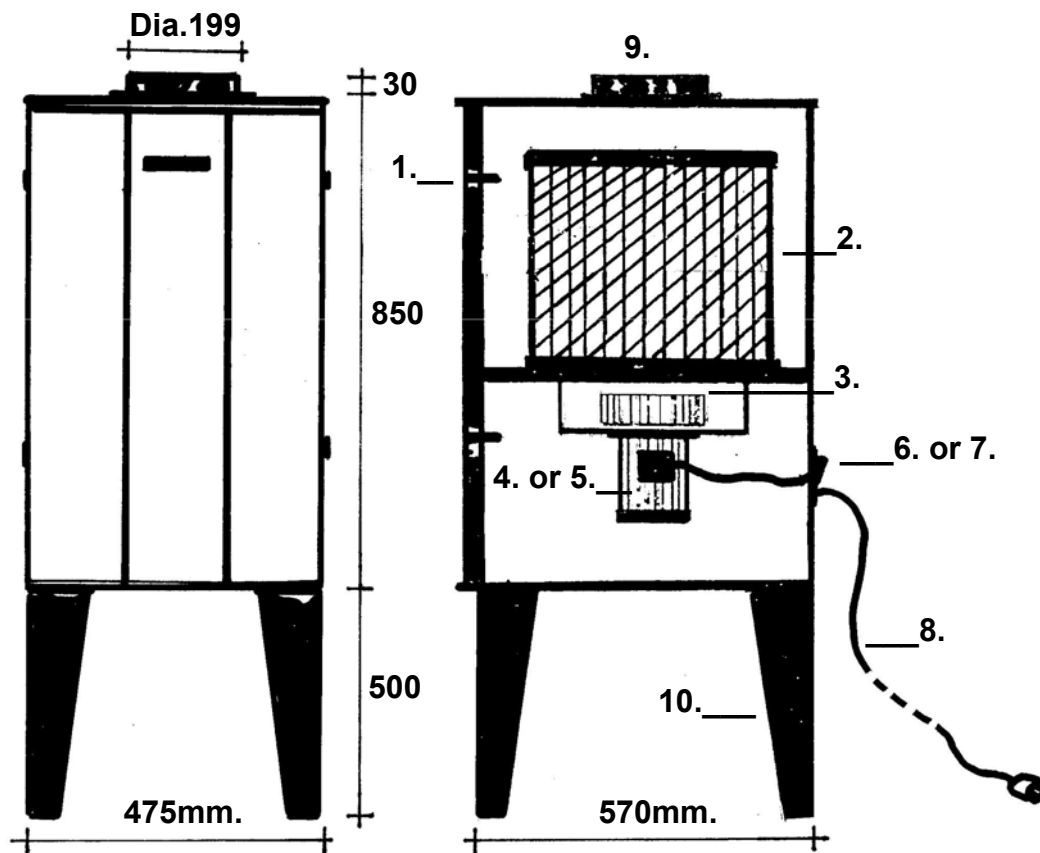
The inlet diameter is 199mm. Use d.200mm Vertical/Horizontal ducting from the CF-LAB and go down with dia.75/100mm ducts to the Flexa/Chemikus Extraction Arms or dia.160mm duct to Flexi dia.160mm Extraction-Arm/Arms.

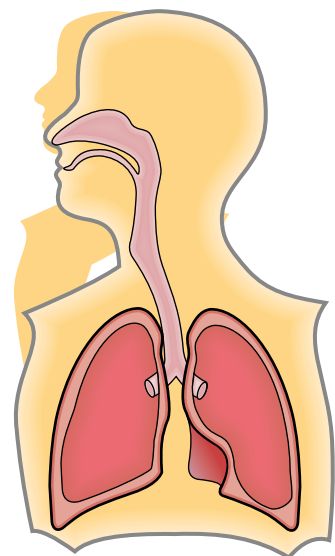
### Vapour from solvents (VOC).

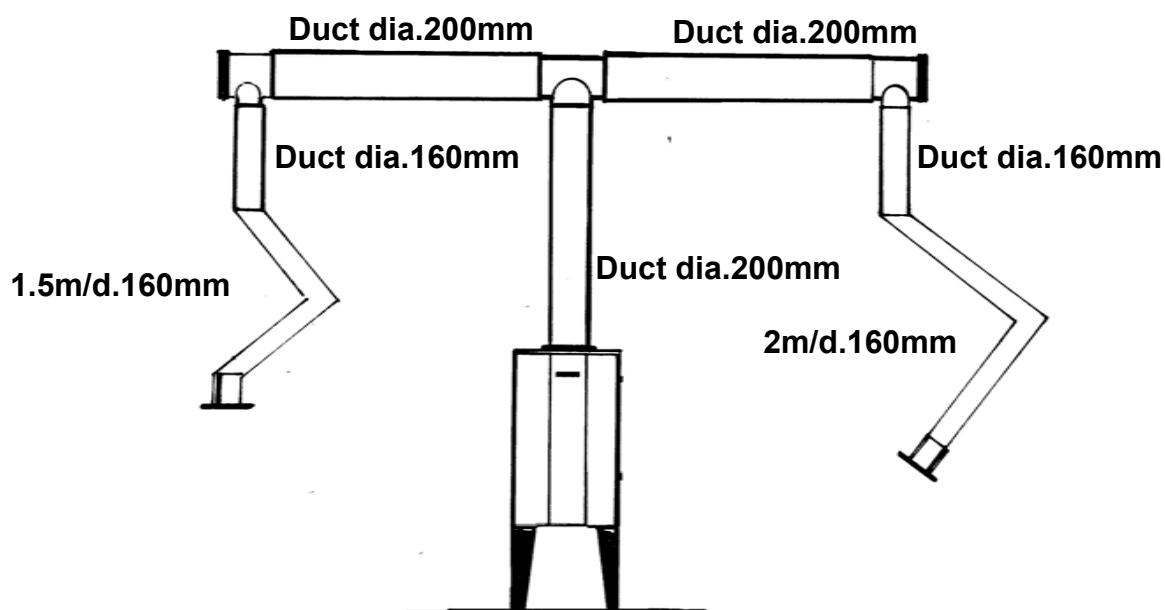
